### A. Herman, Adult Services

# Director's Report K. Naftaly

Ms. Naftaly thanked the Board for giving her the opportunity to travel to Denver for the PLA Leadership Workshop on Social Justice and Public Libraries: Equity Starts with Us. The experience gave her the opportunity to network with librarians from communities of shared demographic make-up as to how their libraries are addressing social inequities. Approximately 90 people attended the conference. Our task now as an organization is to build social equity into our present and future programming. We need to view our community through many different lenses. This may be addressed within the 2019 strategic planning process. Today was Legislative Day and Ms. Naftaly, Ms. Shapiro and SALS constituents met with Senator Betty Little, Assemblyman Dan Stec & Assemblywoman Carrie Woermer. Fortunately for us, they all love libraries. Advocacy Day agenda included \$200M for statewide library aid, \$75M for library construction, \$40M for 2020 US Census count Initiatives and Equitable Access for all New Yorkers.
