Mr. DeGarmo asked her to report that Batman Day will be held on July 23rd. Ms. Shanks asked her to report that Mr. Ed Moore, Sr. will be the recipient of the 2014 Henry Crandall Award. Ms. Shanks sends out a Thank You to Arrowhead Equipment for their donation of \$3,700 from the *Touch a Truck* fundraiser. Ms. Vanderminden asked that Ms. Shanks send the nomination letter to all Board members as not all Trustees know Mr. Moore.

Ms. Naftaly stated she attended the latest Crandall Trust meeting. The investments did well last year and 2015 looks good so far. Crandall Library received the Community Partner Award from the United Way for allowing them to place a food bin in our lobby. Relay for Life asked all downtown businesses to dress in "Purple" during May. We displayed all purple books in our windows. Ms. Naftaly is working on the NYSCA Grant. She is applying for Folk Life and the Film Program. The promotion we had planned to collaborate with TCT Credit Union was nixed by the National Credit Union Association. Membership would have to have been based on a monetary association with the Library.
