ADMINISTRATIVE HISTORY

The Glens Falls Paper Company was incorporated in 1864 and operated a mill on the south side of the Hudson River in South Glens Falls. The firm was reorganized in 1882 as the Glens Falls Paper Mill Company. William E. Spier was President of the Glens Falls Paper Mill Company. George R. Harris was Secretary from 1891-1898; Bryan L. Arlen succeeded him and served through 1905. Other officers were: Frederick H. Parks, Vice President and General Manager; George H. Parks, Treasurer; and W. B. Dillon, Manager, Sales. Other Trustees were Bryan L. Arlen, Hugh A. Bowden, Jonathan M. Coolidge, Byron Lapham, William McEchron, Solomon A. Parks, G. F. Underwood, and William H. Weaver.

SCOPE AND CONTENT OF THE RECORDS

This volume, marked Minutes No. 2, contains the minutes of the Board of Trustees of the Glens Falls Paper Mill Company, 1891-1905, along with a record of the proceedings of the consolidation of the Glens Falls Paper Mill Company and the Fort Edward Paper Mill Company, 1891. Minutes are signed by George R. Harris and Bryan L. Arlen, Secretaries.
